

Chautauqua Guest Homes is comprised of two skilled nursing facilities totaling 126 beds.

Susan Ayers, RN, BSN, LNHA, Administrator, Chautauqua Homes (Iowa), explains: "For a one year period, April 1, 2013, through March 30, 2014, 89% of our admitted residents were placed in wheelchairs. Subsequently, 11% of our admissions were ambulatory. Based on our resident dynamics, there was a real focus placed on preventing patient falls and associated hip fractures".

"Since starting our comprehensive falls reduction program (including the use of ComfiHips®) at the beginning of April 2014, only 42% of new admissions are being placed in wheelchairs while 58% remain ambulatory."

"We believe that ComfiHips® are one of the most important interventions in the prevention of hip fractures when falls do occur and we have confidence that allowing residents to remain ambulatory improves their quality of life while ComfiHips® use lessens the likelihood of major injury should a fall occur."

Ms. Ayers goes on to say:

"We are working on a protocol for new admits that includes monitoring, appropriate bed height, shoes, etc and also ComfiHips® for the first 14 days.
